# GENERAL RELEASE - HOBOKEN SKI CLUB

(Revised as of August 18, 2005)



## PLEASE READ CAREFULLY AND INITIAL EACH PARAGRAPH

I am aware that many of the Club's activities, including skiing, ski racing and ski instruction, are inherently dangerous activities, which involve the risk of serious injury or even death. I understand that the Club is a non-profit organization and that its members, officers, directors, delegates, committee chairpersons, committee members and instructors serve only in the capacity of volunteers. I agree that by participating in any Club-related activity, I am responsible for my own safety and agree that I knowingly and voluntarily assume the risks involved in any such activity. \_\_\_\_\_ **Initial**
